Passed unanimously.

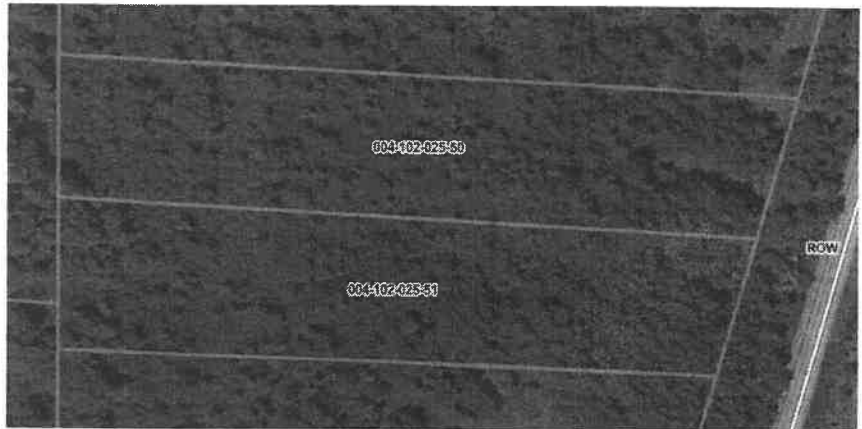
LAND DIVISION RESOLUTION
